




## Citizenship acquisition

- by jure sanguinins, if you have italian parents.
- **by jure solis**, (1) if you are born in Italian territory and your parents are considered either unknown or stateless; (2) if you are born in Italian territory and cannot acquire your parents' citizenship because the laws of the parents' country of origin exclude the acquisition of their citizenship for children born abroad; (3) if you are a child of unknown parents who is found (following abandonment) in Italian territory and for whom it cannot be demonstrated that you possess another citizenship (Art. 1, para. 2).
- by recognition of parentage;
- **by judicial verification**, where adult children retain their own citizenship but can opt for citizenship determined by parentage through a formal declaration.
- Special provisions are established regarding the acquisition of citizenship by foreigners or stateless individuals who **have married** Italian citizens.

# Right to asylum and international protection

- International protection is a set of fundamental rights granted by Italy to refugees and individuals with subsidiary protection.
- **Refugees** are individuals who have a well-founded fear of being persecuted in their country of origin due to reasons such as race, religion, nationality, political opinion, o and who cannot receive protection from their country of origin.
- Subsidiary protection holders are individuals who, while not classified as refugees, are at risk of suffering serious harm in their country of origin.

- as soon as possible
- at the Border Police
- at the nearest Questura Immigration
- at the Center for Temporary Detention for Deportation (C.P.R.)

## Family Reunification

### Who is entitled and how to apply?

- Spouse: Not legally separated and at least 18 years old.
- Minor Children: Including those of the spouse or born out of wedlock, provided the other parent, if present, consents.
- Adult Dependent Children: If they are unable to meet their essential needs due to a total disability.
- **Dependent Parents:** If they have no other children in the country of origin or are over 65 years old, and other children cannot support them due to serious documented health reasons.

Family reunification is not possible with siblings.
If the applicant is already married to another spouse residing in Italy,
family reunification is not allowed.

### • Article 45 - Freedom of Movement and Residence


- 1. Every citizen of the Union has the right to move and reside freely within the territory of the Member States.
- 2. The freedom of movement and residence may also be granted, in accordance with the treaties, to third-country nationals who legally reside within the territory of a Member State.

must be requested within 8 working days at Questura-Immigration








It can be requested for professional lor accademic reasons.

## **Board and lodging**


Accommodation can be obtained through the hospitality of someone else or by renting or purchasing a house.

The certificate of housing suitability is required for all foreign nationals applying for a residence permit for:

- Subordinate and self-employment;
- Family reunification and cohesion (For holders of a residence permit for international protection, proof of suitable accommodation is not required to apply for family reunification);
- EU long-term residence permit.

The documents typically required for submitting an application for housing suitability include:

- Completed application form;
- Copy of the property title (such as the purchase agreement or a duly registered lease agreement);
- Self-certification regarding the existing facilities;
- Copy of the cadastral plan indicating the property's intended use;
- Copy of the valid ID of the applicant;
- Proof of payment of administrative fees and/or stamp duty where applicable.



### Healthcare

The italian law recognises the right to health as a fundamental human right.

Registration has the same validity in time of the stay permit and it can be either mandatory or voluntary.

### Who can apply for voluntary registration?

- Students
- Au pairs
- Holders of a stay permit for elective residence
- Employees of international organizations working in Italy
- Many others

### How to apply for the SSN

- Registration is implemented in the ASL closest to your place of residence.
- A SSN card will be issued, which entitles you to use the Italian public service.
- for Health Emergencies, 118 is the free public emergency service.

## Social Assistance for Migrants

3

Individuals with an EU long-term residence permit can obtain economic social assistance benefits provided they meet the requirement of having legally and continuously resided in Italy for at least 10 years.

Regarding **civil disability**, all foreigners holding a residence permit of at least one year are entitled to the following benefits:

- Attendance allowance;
- Disability pension;
- Monthly disability allowance;
- Attendance allowance for children;
- Pension and allowance for the deaf;
- Pension and allowance for total blindness;
- Pension and allowance for partial blindness.

# Regarding social assistance for mothers...



The **baby bonus** is available to parents residing in Italy who are:

- EU citizens;
- Non-EU citizens with an EU long-term residence permit;
- Citizens with a residence card for family members of an EU citizen (Italian or EU);
- Citizens with a permanent residence card;
- Foreign nationals with refugee status or subsidiary protection.

The "Bonus Mamma Domani," amounting to €800, is granted to foreign citizens regardless of their residence permit status.

# Administrative Procedures for Foreign Nationals

## If you're struggling to get your:

- Residence permits (applications, renewals, and conversions);
- Registration with the National Health System (SSN);
- Tax code (codice fiscale) requests;
- Housing suitability certificates;
- Family reunification procedures;
- Social security and welfare benefits applications;
- International protection and asylum requests;
- Citizenship applications.

## They provide you with the following services:


# Employment centers (centro per l'Impiego)

- **Job Placement:** Assist in finding employment by providing job listings, career counseling, and matching job seekers with potential employers.
- **Skills Assessment and Training**: Offer services to assess skills and provide training or educational programs to improve job prospects.
- Work Permits and Documentation: Help with the necessary documentation for work permits and ensure that job offers comply with legal requirements.
- Career Guidance: Provide advice on job market trends and professional development opportunities.

# Trade Unions (Sindacati)

## They provide you with the following services:

- **Legal Assistance:** support and legal advice regarding labor rights, employment contracts, and workplace disputes.
- **Advocacy:** fair working conditions, equal treatment, and the rights of workers, including foreign nationals.
- **Support Services:** issues such as wage disputes, workplace safety, and workers' compensation.
- Integration Programs: helps foreign workers integrate into the Italian labor market, including language courses and cultural orientation.



## Education and Language Courses

- Italian Language Courses: Offered free of charge by many organizations, schools, and reception centers to facilitate integration.
- Access to Education for Children: Children have the right to free and compulsory education. It is important to learn how to enroll your children in school.
